TERMS AND CONDITIONS FOR ALL VENDORS & SPONSORS

1. Vendor space location to be determined by The Educated Voices Promotions.
2. Load in time begins at 11:00 a.m. and exhibitors must be completely set up by 12 pm. for the Fire Marshall walk through.
The event starts at 12.pm. Load-in & out details will be sent to you within (1) week of the event date.
3. Exhibitors are required to be open from 12:00 pm to 8:00 p.m. CLOSING STAYING OPEN AFTER EVENT IS STRICTLY PROHIBITED AND IS GROUNDS FOR EXCLUSION FROM PARTICIPATION AT FUTURE EVENTS.
4. Only specific sponsors will be provided with a canopy, 2 tables and 2 chairs. All vendors and non-profit exhibitors must provide all of their own rentals
5. All business and other activity, for which the exhibitors have rented space, must be conducted within the designated vendor space only!
6. Exhibitors must post prices in a legible manner and in a visible space within their vendor space.
7. The sale of alcoholic beverages of any kind is strictly prohibited.
8. Consumption of alcoholic beverages by exhibitors, volunteers or employees of vendors at their booth is prohibited.
9. Exhibitors must provide trash receptacles for waste generated by their booth. Improper trash disposal is grounds for exclusion from participation at future events.
10. You are required to obtain and display all necessary permits and / or licenses. The Educated Voices, York Soul Promotions are not liable and will not refund any fees or deposits. Educated, and City of York will not be liable for any lost, stolen or misplaced merchandise or equipment at the event.
- 12.REFUNDS: Your vendor space fee is NON-REFUNDABLE, regardless of vendor space placement, sales or competing vendors.
15. FOOD VENDOR SPECIFIC REGULATIONS:
 - a. All food vendors must meet and follow all City of York Health Department and Fire Department Guidelines.
 - b. You must obtain a City of York Health Permit (Call 717-849-2256).
 - c. All food items must be stored inside the allotted space, covered and off the ground.
 - d. York Health Department requires that you provide appropriate cleaning materials as well as a handwashing setup. *Running water is not provided on the grounds of the event.*
 - e. Containers of butane or fuel must be affixed to a post or other secure item.
